2020 Breast Surgical Fellowship Grant

Mission Statement:

The mission of the Breast Cancer Alliance is to improve survival rates and quality of life for those impacted by breast cancer through better prevention, early detection, treatment and cure. To promote these goals, we invest in innovative research, breast surgery fellowships, regional education, dignified support and screening for the underserved.

To accomplish this, the Breast Cancer Alliance:

- Funds a diversified portfolio of breast cancer research
- Funds Breast Surgery Fellowship programs
- Provides timely information on breast health and the importance of early detection
- Supports outreach and case managerial services, education, counseling and mammograms for underserved women in mid to southern Connecticut and Westchester County, New York

Terms:

The term of the Breast Surgical Fellowship is **one year** with a grant award of \$75,000, from August 1 through July 31. Institutions making application for the 2020 award must have an established breast fellowship program, be SSO accredited for a minimum of two years, and be located in New York, New Jersey or Connecticut.

Any publicity associated with this program must recognize the Breast Cancer Alliance as a sponsor as much as reasonably possible and be recognized in any papers published in association with work done during or as a result of this fellowship.

All applicants must be US citizens, be a MD, and have successfully completed a general surgery residency at a US medical center. No more than one fellowship will be awarded to any individual SSO accredited institution.

Application procedure:

Grant applications will be available on our website. Final applications must be emailed to fellowships@breastcanceralliance.org on or before December 10, 2019. Please adhere to the format as specified. Font style should be 12 point, Times New Roman. In addition, one hard copy must be mailed to the Breast Cancer Alliance office.

Recommendations are made to the BCA Board for final approval. Applicants are notified by e-mail no later than mid-January 2020 of the decision regarding their proposals.
